- 1. Fr. Mark opened the meeting at 9:40 am with a prayer.
- 2. Ginny Grant requested any additions or corrections to the Minutes of the November 2, 2023, Minutes. One correction: Change Dave Kelly to Matt Kelly. Minutes were approved without Fr. Mark's approval. (Fr. Mark will no longer be approving Minutes prior to distribution to members.)
- 3. This meeting served as the ANNUAL MEETING OF SAINT BRENDAN THE NAVIGATOR

CATHOLIC PARISH OF SHALLOTTE. With a voting quorem present, the Directors of the Corporation were elected for the calendar year 2024. They are Most Rev. Luis Rafael Zarama, Bishop of the Diocese of Raleigh, Very Rev. Michael J. Burbeck, Vicar General of the Diocese of Raleigh, Rev. Mark J. Betti, Pastor of the Parish, Jack Semanko, President of the Parish's Finance Council and Ginny Grant, President of the Parish's Parish Council (aka Pastoral Council). Also elected were the officers for 2024: Rev. Mark J. Betti, President, Very Rev. Michael J. Burbecki, Vice President, Jack Semanko, Treasurer and Ginny Grant, Secretary.

- 4. **FINANCE**—Jack Semanko introduced the members of the Finance Committee. Thanked Rob Edwards for his efforts in preparing for this meeting. Fr. commended the Finance Council on their superior job. Continue to meet financial obligations. In an effort to build up our reserves to a 6-8 week buffer, we will discontinue additional principal payments. Anticipating a 3rd priest in June (if Visa requirements are met), will entail a new rectory which conforms to Diocese requirements. We are pricing out in order to coordinate with the Diocese, we will increase our debt but offset it with the sale of the current rectory. The moratorium in spending continues—emergencies only with the approval of Fr. Mark and the Finance Council. Hall expansion, hall renovation and kitchen expansion are on hold for 5 years. As per plan, parking lot expansion is next.
- 5. **ST. MICHAEL MINISTRY**—See report attached. It was noted that on two occasions, persons were locked in the church with alarm set. Ron will again remind members to be certain all persons are out.

Roundtable input:

- Father Mark gave Pastor's Incorporation Book to Rob Edwards to update. Father will deal with items to be submitted to lawyer.

- AA Meetings will be held beginning in January, 2024, in Conference Room II, on either Tuesday or Wednesday evenings.
- Father Mark is donating his second car to the Diocese for use by the parish house.
- Father Mark is addressing questions in next bulletin to correct rumors.
- In 6 years when hall expansion is complete, there will be additional classrooms and a choir room.
- Presentation given by Charles McShane re. proposal from Lower Cape Fear Life Care (LCFLC), Carrie Dunlap, Community Engagement Coordinator, to present a two session program at St. Brendan which would focus on Hospice and Palliative Care and Advance Directives and Living Wills. See attached Proposal for detail. Program is to be informational only and not a recommendation of their services. Proposal was approved by the Council subject to clarification that their program will be in keeping with Roman Catholic doctrine. Charles will coordinate with Kathleen Brandenburg, Human Life and Dignity. A Spanish language brochure will be made available. During 2nd session, representatives will be on site to assist in preparing documents and notarizing.

Lower Cape Fear Life Care (LCFLC) 2024 - Proposal presented by Charles McShane Carrie Dunlap, Community Engagement Coordinator

LCFLC offered our Memory Education Session in May which was well received by 60 parishioners. They have called to offer further education on various programs they offer to the community of New Hanover and Brunswick Counties.

My recommendation is we build a 2 session program of about 45 minutes each offered after a 9:00AM weekday Mass in March and May 2024.

Session 1 Focus on Hospice and Palliative Care

- Hospice navigating needs and support goals of care during last months of life. Only 10% of LCFLC patients take advantage of full Medicare hospice benefit includes ALL medical care, medications, equipment and visits related to to diagnosis.
- Palliative Care help people living with serious illness example: heart disease, COPD, cancer, dementia, Parkinson's and ALS. Medicare can help with nurse support.

Session 2 Focus on Advance Directives and Living Will. Give some set-up background in Session 1 allowing attendees to plan for this session to gain full benefit.

 Advance Directive and Living Will – Address healthcare advocate identification that can speak on behalf of a person in declining health. Organ donation and other issues. Healthcare only – NO Financial matters.

LCFLC will provide needed documents and notary for those interested at no cost for 1 or both directives.
